d) President

- Pleased to see memberships (skaters, coaches, officials, and volunteers) on the rise in the entire NWT in 2024-2025, 10 members in Hay River, 23 in Inuvik, 25 in Fort Simpson, 152 in Yellowknife, continue to focus on our mandate to provide accessible, safe, and fun skating in the territory.

e) Treasurer

- 2024/2025 financial statement as of March 31, 2025 tabled, approved May 22, 2025.
- Thanks to Jody for finding additional funding (\$22.5K).
- WLCP funding does not increase in an AWG year, funding has remained consistent at \$82.5K since pre-2020.
- Revised Travel Funding Policy (August 2025), changed from two southern meets to one.

f) Clubs

- Fort Simpson – successful year, quite a few skaters in Learn to Skate in addition to two levels of skating (SS1 and SS2); traveled to YK Ability Meet, Debby Fisher's RU Fast, and NWT Champs, one skater went to CYSTC-West; ran First & Fast Strides Program and running again in 2025-2026, purchased new swag; windup at new tourism camp, summer 2025 biking program.
- Hay River – in 2024-2025, there were eight skaters on ice and ten athletes participating in dryland training; Jaxin competed at CYSTC-West, two younger skaters raced at the Peace River meet; hosted the Hay River Fall Camp in October 2024, which included nine athletes from Peace River and Hay River.
- Inuvik – finished community registration night (20+ registrants for 2025-2026); RYSE Funding application submitted, KidSport application submitted for equipment; Dalton and Liam to help with coaching in 2025-2026; new signing authorities for the Board, fundraising bingo and Christmas activity planned.
